2. The sites are auctioned on "AS IS WHERE IS" BASIS and the bidder is deemed to have inspected the sites and also obtained clarifications, if any, from the Society on all issues, prior to the auction. The proposed sites are duly marked in the layout plan and exhibited at the Society Notice Board for the convenience of the intending members.

3. The Bidders are requested to collect the documents of above sites which are available at Society and get it legally verified from your Advocate before participation in auction.
4. The members who are interested to participate in the auction are requested to submit application along with EMD of Rs.1,00,000/- by way of "Demand Draft"

**The member who have already paid Rs.1,00,000/- (Rupees One Lakh Only) as Earnest Money Deposit (EMD) by way of "Online" need to submit fresh application only and are eligible to participate in the auction. Members who have submitted Demand Draft can take back and give fresh Demand Draft along with fresh application. The Demand Draft should be drawn in favour of "BEECHBS Ltd."**

5. The application form for participation in the auction will be issued from 26-03-2026 during the working hours of the Society. The Earnest money deposit along with the application will be accepted in the Society from 26-03-2026 to 03-04-2026 (before 5.15 PM) after verification of the membership details.

No other form of payment towards Earnest money deposit will be accepted. Adjustment of members' amount held by the Society, if any, is also not permitted.


6. The initial bid price has been fixed at Rs.2050/- per Sft. The minimum raise in bid price in multiples of Rs.25/- per Sft. The successful bidder has to pay the total cost of the site as given below:
- a) The total amount payable for the site will be arrived based on the correct dimension.
  - b) 25% of the site cost (including Earnest money deposit) within 15 days from the Date of auction.
  - c) Balance 75% of the site cost within 45 days from the date of auction.

No extension of time shall be permitted for payment beyond the period mentioned above. Any delay in the payments as above by the successful bidder shall lead to automatic cancellation of the auctioned site. In such an event, Rs.75,000/- (Rupees Seventy Five Thousand Only) Earnest Money Deposit amount will be forfeited.

7. No disputes what so ever shall be entertained once a member becomes successful bidder in the auction.
8. The Earnest money deposit (EMD) will be returned to the unsuccessful bidders within one month from the date of auction.
9. The Auction of the sites is exclusively subject to the decision and discretion of the Society.
10. The Society reserves the right to accept or reject any or all the applications and accept or reject the bidding without assigning any reason thereof and the decision of the Society will be final and binding on all concerned.
11. If the auction proceedings remain incomplete, the Society reserves the right to continue / re-auction at a later date.
12. The order of auction of the sites will be as indicated in the details of sites for auction.
13. Only the applicant members with their spouses are allowed inside the auction hall. No other persons are allowed.
